- Conducting risk assessments to evaluate our supply chains for potential vulnerabilities.
- Vetting new suppliers through a rigorous onboarding process.
- Reviewing existing supplier relationships to ensure continued compliance with anti-slavery standards.

5. Training and Awareness

We provide training to our employees to help them recognise the signs of modern slavery and understand their responsibilities in upholding our standards. Specific training is provided to staff involved in procurement and supplier management.

6. Performance Indicators

To measure the effectiveness of our efforts, we monitor and report on:

- The number of suppliers audited for compliance with our anti-slavery standards.
- The percentage of employees trained on modern slavery awareness.
- Any reports or incidents related to modern slavery.

7. Looking Ahead

In the coming year, evcoms is committed to further strengthening its approach by:

- Expanding supplier audits.
- Enhancing employee training programmes.
- Collaborating with industry partners to promote best practices.
